During adolescence, young people are exposed to a range of risks beyond their family homes including sexual and criminal exploitation, peer-on-peer abuse and gang-related violence. However, it has only been over the past two decades that the critical safeguarding implications of these harms have started to be recognised. Social care organisations are increasingly experimenting with new approaches but continue to experience challenges in supporting affected young people and their families.

This book analyses the results of the first rapid evidence assessment of social care organisations' responses to risks and harms outside the home across 10 countries. The authors highlight key areas for service development, give insights into how these risks and harms can be understood, and consider wider implications for policy and practice.

Our first fully open access title, Global Social Challenges Journal (see pages 5 & 6 for full details) is of central importance to our aims as a Press. The first issue is now available to read on Bristol University Press Digital bristoluniversitypressdigital.com.

We are also delighted that our journals Emotions and Society, the European Journal of Politics and Gender, Global Discourse, the Journal of Psychosocial Studies, and the Journal of Public Finance and Public Choice have all been accepted into the Emerging Sources Citation Index and will now get Impact Factors from 2023. Additionally, in just its 5th year of publication, the European Journal of Politics and Gender achieved a Scopus CiteScore of 3.9 and now ranks in the 91st percentile of Political Science and International Relations journals in Scopus.

In the 2022 Impact Factor release, Evidence & Policy substantially increased its 2-year Impact Factor to 2.595 and is now in the second quartile of Social Sciences, Interdisciplinary journals. Policy & Politics continue to rank in the top quartile of Political Science journals in the Social Science Citation Index, and all other journals increased their Impact Factors.






